By completing your registration and accepting this agreement, you acknowledge the inherent risks associated with athletic participation and social gatherings, and you consent to our media release terms. Please review the terms below carefully.

1. Assumption of Risk I understand and acknowledge that participating in Courts & Cocktails activities—including tennis matches, clinics, watch parties, charity initiatives, and social gatherings—carries inherent risks. These include, but are not limited to:

- Bodily injury, illness, or physical strain
- Property damage or loss
- In rare circumstances, permanent disability or death

I voluntarily participate with full awareness of these risks and agree to assume complete responsibility for any personal injury or property damage, whether known or unknown.

2. Waiver and Release of Liability In consideration of participating in Courts & Cocktails programs and events, I—on behalf of myself, my heirs, executors, and assigns—hereby release, waive, and forever discharge Courts & Cocktails Tennis Club, its leadership, board members, volunteers, sponsors, and venue hosts from any and all claims, liabilities, demands, or causes of action arising from my participation. This release extends to claims arising from ordinary negligence, to the fullest extent permitted by law.

3. Alcohol Consumption & Social Responsibility I acknowledge that alcoholic beverages may be served or consumed at select club functions, watch parties, and resort socials. I agree to:

- Consume alcohol responsibly and adhere strictly to all legal drinking age laws (21+).
 - Assume sole responsibility for my conduct, safety, and transportation during and following club events.
 - Hold Courts & Cocktails harmless from any claims, damages, or injuries related to alcohol consumption.
